Two full time staff and 2 part time staff members were let go . Traveling Stories moved out of its office and had remaining employees work virtually from home. March - COVID-19 required us to close all our in-person StoryTent programs. Traveling Stories created the new Reading Raffle app, an app that lets children submit written and illustrated book reviews for chances to win a weekly prize giveaway. The app is free to download on the app store or google play. May - began developing a new online program called the Virtual StoryTent. The Virtual StoryTent matches children in Kindergarten through second grade with mentors for weekly, one-on-one reading sessions via video. Children earn virtual Book Bucks for books read and use their Bucks to buy prizes through the organizations new online prize shop. Prizes are then delivered to children by mail. Got the PPP loan and hired a full-time web developer and full-time program staff member. Was named Humble Bundles Feature Charity for May which resulted in a one-time donation of apx. \$520,000. August and November - conducted 2 pilot programs with nearly 100 participants to test the new Virtual StoryTent program. November - redesigned its website to reflect its new programs . Adopted a new mission statement: Empowering children to achieve their dreams. This replaced the old mission statement which was empowering children to outsmart poverty.</p>
